



## Skijoring at Rebecca Farm Competitor Waiver and Release Form

By signing this waiver and release disclaimer for Skijoring at Rebecca Farm to be held December 28-29, 2019 in Kalispell, I acknowledge, agree with and understand the statements below.

I understand that horseback riding, racing, and skiing behind a horse will expose me to above normal health risks and agree to assume and accept the risks related to these activities. I fully understand that engaging in the sport of Skijoring is dangerous and unpredictable, and can result in severe injury, paralysis or death.

I agree that all decisions I make, and actions that I take, are my own. I acknowledge that my participation is voluntary and at my own risk. I agree that I am responsible for my own safety.

Further, I agree that I will pay for any and all medical expenses, or damage to property, that I may suffer, cause or incur as a result of participating in this event.

On behalf of myself, my heirs, executor and administrators, I hereby release, waive and forever discharge Montana Equestrian Events, Inc., Louisiana Land and Livestock, LLC, event host and facility owners, respectively, their officers, directors, employees, and volunteers, as well as the Skijoring at Rebecca Farm organizing team and staff, Skijoring America Board of Directors and members, vendors, and sponsors who are involved, from all rights or claims for damage which I may have now or in the future, arising from or related to any bodily or personal injuries, death or property damage, which may be associated with the production of, or my participation in, Skijoring at Rebecca Farm.

I understand that event officials may disqualify at any time, any person or team they deem to be acting in an unsportsmanlike manner, including but not limited to, during competition, at registration, at the Calcutta or at the Awards. If I am disqualified, I surrender my entry fees and forfeit any event or Calcutta winnings.

I irrevocably grant to Skijoring at Rebecca Farm and Montana Equestrian Events organizers, staff, officials, photographers and/or media representatives the right to use my name, image, likeness, voice, biography or comments to help publicize and promote Skijoring at Rebecca Farm, Skijoring America and the sport of skijoring, in all media and by all means now known or hereafter devised, in perpetuity.

For Horse owner and/or Rider only: I fully understand that I am responsible for the health and safety of the horse. I waive and release all rights or claims in case of injury and/or death of the horse. I also understand I am fully responsible for any expenses incurred if the horse is injured, or for any actions the horse may take causing injury or damage to humans, livestock or property. I am aware it is recommended that all horses be outfitted with bell and splint boots on each foot.

I acknowledge that I have read and fully understand this agreement and that I sign it voluntarily.
