

Waiver and Release of Liability/Emergency Contact Info

- All individuals who enter the grounds must provide emergency contact information and have a signed Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement on file with the show office.

COVID-19 Exposure:

- Anyone who is exhibiting COVID-19 symptoms, has tested positive for COVID-19 within last two weeks or has been in contact with someone who tested positive for COVID-19 within the last two weeks, cannot enter the competition grounds. *Exception: Healthcare personnel who have treated patients using appropriate medical-grade PPE during the course of performing professional duties.
- Any individual who was on the grounds during the competition and tests positive for COVID-19 within 14 days of conclusion of the competition must immediately notify sarah@rebeccafarm.org, christina@grayareaevents.com and ksacco@usef.org.

Temperature Monitoring:

- All individual's temperatures will be taken at entrance gate daily from 7-5. Subsequently, all individuals are required to take their temperature daily and keep a log of that information in their phone's note or on a note pad. Anyone with a temperature of 99.5 degrees or higher may not enter the grounds. If they are camping/staying on the grounds they must arrange to leave immediately. Temperature logs are subject to review, upon request.

Facemask/Face Covering:

- All individuals are required to wear a facemask or face covering while on competition grounds when in any setting where there is a possibility of being within six feet of other individuals, and when not mounted on a horse.
- **Members of the same household are still required to wear masks or face coverings when there is a possibility of being within six feet of any other individuals, including members of their own household.**
- All individuals are required to wear a mask or face covering at all times when in a **designated "Mandatory Mask Zone"**, regardless of ability to maintain social distancing.

Social Distancing/Participation Protocols:

- All individuals must practice social distancing (or physical distancing) at all times while on the competition grounds by staying at least 6 feet (about 2 arms' length) from any person who is not a member of their immediate household.
 - **Members of the same household are still required to wear masks or face coverings when there is a possibility of being within six feet of any other individuals, including members of their own household.**
- Wash hands often and adhere to other sanitization practices throughout the day.
- Sanitize warm-up jumps with provided materials. It is recommended to wear gloves while handling jumps.

Spectators:

- Spectators are not allowed.
- Support individuals for riders are limited to a groom, coach, vet, and one additional person for a minor competitor. These individuals are also required to sign the Waiver and Release of Liability agreement and register emergency contact information [here](#), monitor their own daily temperature, and follow all Facility Protocols & Safeguards.

Barn Access:

- Stabling is restricted to athletes, officials, grooms, trainers, parent/guardian of minor, veterinarian and farrier.

The USEF COVID-19 Action Plan Requirements and Recommendations found on USEF.org will supersede the above list.

Enforcement: USEF Stewards and Technical Delegates will inform individuals when they are not in compliance with the regulations and requirements in effect at the competition and shall report such situations to the Competition Organizer. The Competition Organizer has the authority under GR 702.1 and GR914 to remove from the facility any person who does not comply with the regulations and requirements in effect at the competition. Stewards/Technical Delegates must report the removal of any person from competition grounds for non-compliance with regulations and requirements in effect at the competition in their USEF Steward/Technical Delegate Report.
