### WAIVER AND RELEASE OF LIABILITY, Assumption of Risk and Indemnity Agreement

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") and the United States Eventing Association, Inc. ("USEA") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF and USEA sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and <u>("USEF/USEA Event"</u> or "USEF/USEA Event" or "USEF/USEA Event" or "USEF/USEA Event"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual repre-sentations pursuant to this Agreement (the "Agreement"):
