CLASS RESTRICTIONS

HUNTER

18" Hunter Division - Horse/rider combinations may not compete at this show in any class with fence heights above 2'3". Cantering is optional.

2' Short/Long Stirrup Division - Restricted to Junior and Amateur riders. Horse/rider combinations may not compete at this show in any class with fence heights above 2'3".

Trotting is not penalized.

Pony Hunter - Restricted to ponies 14.2 hands & under. Must have Pony Card. MHJA, USEF or EC are acceptable. May be exhibited by an Adult if suitable in size.

2'3" Hunter -Horse/rider combinations may not compete in classes over 2'6" at his show.

EQUITATION

2' Equitation - Horses and ponies to be shown by Juniors and Adult Amateurs only.

2'3" Equitation - Horses and ponies to be shown by Juniors and Adult Amateurs only.

2'6" Equitation - Horses and ponies to be shown be Juniors and Adult Amateurs only.

3' Equitation - Open to all horses, ponies and riders.

HIGH JUMP

Low - Open to horses showing in classes 2'9" or .85m and under. No cross entry allowed into High Division.

High - Open to horses showing in classes 3' or .90m and over. No cross entry allowed into Low Division.

HUNTER PAIRS

Open to all horses/ponies and riders. First 4 jumps to be rode with Rider A in the lead and next 4 with rider B in the lead. Final jump to be jumped tandem. Judged as a Field Hunter with emphasis on turn-out, pace and uniformness.

OPPORTUNITY CLASSES

There is no MHJA Membership required. However, if points are to be accrued through USHJA, you must become a USHJA Outreach Member. This is free if you are a MHJA member. Information may be found on the USHJA website under the Showing and Outreach tabs. Opportunity Classes are not MHJA rated and riders may not cross enter into the rated classes at this show. These are entry level classes.
